## GOVERNMENTAL AFFAIRS & PUBLIC RELATIONS COMMITTEE UPDATE

NAME and several of its partnering organizations continue to be in regular contact with the Office of Special Education (OSEP) concerning the IDEA regulation requiring parental consent to bill Medicaid [34 CFR §300.154(d)(2)(iv)(A)]. In its joint 2009 NAME Conference presentation with Centers for Medicare and Medicaid Services (CMS) last October, OSEP announced that it anticipated issuing further guidance on this topic in November, 2009; but recent correspondence indicates OSEP is still reviewing the matter. NAME continues to remind OSEP that this requirement imposes undue administrative burdens and results in lost revenues for our nation's public schools, which are under increasing financial stress. No other Medicaid provider is required to obtain consent prior to billing Medicaid. This parental consent regulation is arduous for schools in terms of obtaining and maintaining current signatures and lost revenue associated with inability to obtain signatures for a multitude of reasons.

## BIENNIAL SURVEY UNDERWAY

Did you know that 100% of the states responding to NAME's 2007 biennial survey, 100% reimburse schools for OT, PT and speech services on Individualized Education Programs (IEP) and that only about a third of the responding states cover orientation and mobility services on IEPs? NAME's biennial survey was sent to both State Medicaid and Education Agencies in early December. Please do your part to make sure that every state submits a completed survey this year. Those from state agencies, please take about 30 minutes to complete the survey if you have not already done so; those from a Local Education Agency or Vendor Agency, please contact your state agency and encourage them to complete the survey. This data is critical to the success of all of our members and the children we serve.
