Organization Structure

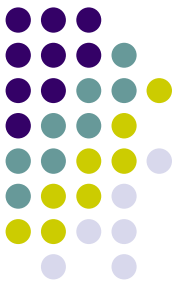




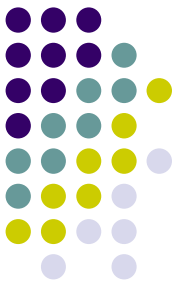

This Past Year in NAME



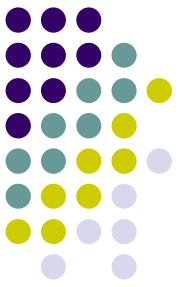
- Rescission of CMS Rule 2287

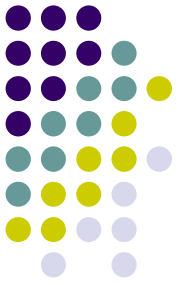
